The Chairman, Senate extended warm welcome to the members and thanked them for taking their time out to attend the meeting.

Agenda item-wise proceedings of the meeting are as under:

Item No. 53.01

To confirm the minutes of Fifty-second (52nd) meeting of the Senate held on November 27, 2015.

Resolution

The Senate confirmed the minutes of its Fifty-second (52nd) meeting of the Senate held on November 27, 2015 with the following observations.

- (a) The Senate considered the observations made by Prof. M. M. Gore that name and tenure of Prof. Geetika as Chairman SDPC shall also be included in the Item No. 52.07(b). Further that the tenure of three Chairmen shall be of two years' duration as mentioned in the Institute Ordinances. The Senate resolved to accept the changes in its earlier ratification and bring the same on records.
- (b) The Senate considered the observations made by Prof. P. P. Sahay, Prof. P. K. Dutta and Dr. Anjana Pandey on the matter of Mr. Md Zikrullah Shamim (Enrollment No: 2013RBT01), a Ph.D. student of Department of Biotechnology. Some new facts were presented before the Senate by the Head of the Department. Looking at those facts the Senate felt that the student had not concealed any fact in his application. The Senate further observed that the eligibility in respect of percentage of marks/ CPI is not categorical enough to warrant termination in this case. Keeping in view of those facts the Senate after deliberations resolved to permit the student to continue in the programme by giving him benefit of doubt. The Senate further resolved that the eligibility condition in respect of percentage marks/CPI should be explicitly spelled out to avoid any such complication in future. The Senate also resolved to place on record that in future this consideration should not be quoted as precedence.

Item No. 53.05 : To consider the recommendations of the Chairman, SDPC.

Resolution

The recommendations of the Chairman, SDPC on the request of following students of Doctoral programme were put up before the Senate by the Chairman, SDPC for case by case consideration.
