Resolution : The Senate confirmed the minutes of its Fifty-third (53rd) meeting of the Senate held on January 18, 2016 and the Thirteenth (13th) Emergent meeting of the Senate held on March 21, 2016.

Item No. 54.02 : **To consider the action taken on the decisions taken in the Fifty-third (53rd) meeting of the Senate held on January 18, 2016 and the Thirteenth (13th) Emergent meeting of the Senate held on March 21, 2016.**


