Item No. 57.03 : To consider the recommendations of the Chairman, SUGC.

Resolution : (i) The recommendations of the Chairman, SUGC, on the request of the following students of Bachelor of Technology programme for granting semester leave for Even Semester 2016-17, were placed before the Senate and the Senate resolved to allow for the same.

(ii) The Senate considered the recommendations of SUGC regarding academic curriculum of Under Graduate Programmes and resolved that the modified syllabus and proposed course structure shall be routed through respective DUGC and SUGC (if not done earlier), as per Ordinances. Further, it is resolved that the modifications, as recommended by DUGC/SUGC be circulated among the members of the Senate for comments before placing it for consideration of the Senate in its next meeting.

The Senate further resolved that Departments may hold a curriculum development workshop during summer vacation with participation from the industry, especially the recruiters.

Item No. 57.04 : To consider the recommendations of the Chairman, SMPC.

Resolution : The recommendations of the Chairman, SMPC on the request of following

students of Masters' programme were put up before the Senate by the Chairman, SMPC for consideration on the case to case basis. The Senate resolved as below:

- (i) The Senate considered the recommendations of SMPC regarding the absence of Mr. Aditya Agrawal (2015CL10) Chemical Engineering Department from 11.11.2016 to 24.11.2016 due to Dengue fever. The Senate resolved to grant admissible leave with the stipend and remaining period without stipend.

However, the candidates shall be required to produce 'No Objection Certificate' from their employers and fulfill the residential requirement for the programme as per the Ordinances.

- (vii) The Senate considered the recommendations of SMPC regarding grant of leave to Mr. Akshay Tiwari (2016FE09) from 13.5.2017 to 17.7.2017 to attend summer fellowship programme in IIT Madras during 16.05.2017 to 15.07.2017 at IIT Madras. Senate resolved to accept the recommendation of SMPC as per **Clause 6 of the Ordinances for Master's Programme: Permission to Proceed to Other Academic Institutions as Non-Degree Students**. However, as per the recommendation of SMPC, Mr. Tiwari has to submit a detailed report on work/ study completed during the summer fellowship programme. He has to submit a certificate from the faculty in charge of the summer fellowship programme regarding his stay during the programme at IIT Madras and successful completion of the programme. Failing which this leave shall be treated as absence without any sanctioned leave.
- (viii) The Senate considered the recommendations of SMPC regarding declaration of result of Mr. Rajat Kapoor (2012PTSW24). Mr. Kapoor was not registered in the Even Semester of academic session 2015-16 and presented his thesis in the odd semester of session 2016-17. 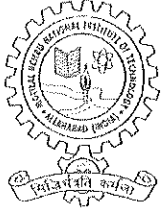

(1.1) It was found that students at sl. No. 01 to 14 had sought permission for late registration through concerned Department due to internship / conference / medical ground / train derailment etc. and the respective DUGC / DMPC have recommended that they be allowed to register.

The Committee recommends that these students may be allowed to register after paying fine of ₹ 500.00, as was applicable till 30.12.2016 for late registration.

(1.2) The students at sl. No. 15 to 49 did not register within the given time including extended time till 30.12.2016 and the reasons given by them are not considered justified for the delay.

The Committee recommends that as a measure to deter such practice, these students may be allowed to register after paying a fine of ₹ 500.00 per day with effect from 31.12.2016 till the date of application received with a maximum of ₹ 5,000.00. The students may be allowed to register latest by 14.01.2017 at the Office of the Dean (Academic) after paying the late fee.

Any student reporting thereafter may not be allowed to register and may be advised for Semester Leave as he/she will not be able to complete attendance requirement.

Further, the Committee resolved that all the students who are granted permission for late registration shall be required to complete attendance requirement of 75%. The total number of classes will be counted with effect from the date of commencement of classes, i.e. 22.12.2016.

The Committee took serious note of the occurrence of Grade Discrepancy in every semester and resolved that extreme care should be exercised in grade submission to maintain the sanctity of examinations.

5. (i) The Committee resolved that **Mr. Atul Jaiswal** (Registration No. **2010RCE10**), may be allowed three month extension of the Ph.D. programme in the even semester 2016-17, as per recommendation of SDPC.

(ii) The Committee resolved that **Ms. Deepika Srivasatava** (Reg. No. **2010REE55**), may be allowed for extension of six month in the even semester 2016-17, as per recommendation of SDPC.

semester of session 2015-16 was considered by the Senate in its meeting held on 14.6.2016 and was allowed to register in session 2016-17 to submit his thesis for evaluation but he did not register himself in odd semester of session 2016-17.




Mr. Saurabh could not appear in end semester examination of odd semester of session 2016-17 due to accident. He has submitted medical report also. On the recommendation of SMPC, the Committee recommends that the candidate may be allowed to register in odd semester of session 2017-18 to continue his programme.

(iii) The Committee considered the case was of **Mr. Paramhans Singh (2013ST22)**. The senate in its meeting held on 14.06.2016 had resolved that the student shall appear in Supplementary Examination 2016 to clear ACD and register in session 2016-17 if he clears his ACD. Further extension of his M.Tech. programme for one more year (more than three years) as a special case was also allowed. Now, after completing his ACD and registering in odd semester of session 2016-17, the students had written application to consider his stay in the Institute from 11.8.2015 to 31.7.2016 to complete the residential requirement. The student had applied leave to his employer (Indian Railway) on 07.7.2015 which was sanctioned on 14.3.2016 with effect from July 2015. In anticipation of sanction of leave he had stayed in the department to complete his residential requirement. As per his application now Indian Railway will not sanction any further leave. SMPC has recommended to consider his stay of 2015-16 as fulfilment of the residential requirement.

The committee resolved that the candidate had completed one year of residential requirement (Odd and even semester of session 2013-14) while during odd and even semester 2014-15, he was on semester leave. **Mr. Paramhans Singh (2013ST22)** stayed in the department during odd and even semester of session 2015-16 after registration. The Committee recommends to consider his stay during odd and even semester of session 2015-16 in department as fulfilment of residential requirement.


for odd semester of session 2016-17 as he was selected in NBCC (India) Limited on 29.6.2016. He has requested semester leave for even semester of session 2016-17 also. Mr. Ashwani is selected in Indian Railways. His current CPI is 7.67. On the recommendation of DMPC and SMPC, the Committee recommends semester leave for them.

(v) Committee considered the recommendation of DMPC of Civil Engineering Department and SMPC, regarding semester leave for odd semester of session 2016-17 to **Mr. Sarfaraj Khan (2014GE11)** and **Mr. Anoop Singh (2014GE06)**. The Senate in its meeting held on 16.08.2016 resolved (Item No. 55.04 (v)) that "department will first submit the marks (report), then these students may register in odd semester of session 2016-17 to complete the programme". Supervisors have submitted report of M.Tech. thesis examination of these students to Faculty-in-Charge (Examination) on 30.09.2016. Committee recommends that semester leave for odd semester of session 2016-17 may be granted to these students and they may be allowed to register in even semester of session 2016-17 to complete the programme.

(vi) Committee considered the recommendation of DMPC of Civil Engineering Department and SMPC, regarding semester leave of **Mr. Govind Verma (2015ST13)**. His current CPI is 6.1. He got a job in Delhi Metro Rail Corporation Limited. He was to join there on 19.12.2016. Committee recommends semester leave to the student for even semester of session 2016-17.

(vii) Committee considered the recommendations of DMPC of Mechanical Engineering Department and SMPC, regarding mercy appeal of **Mr. Vinay Kumar Gupta (2016CC07)**, **Mr. Abhishek Gautam (2016CC18)** and **Mr. Deepak Tripathi (2016CC20)**. They got CPI equal to 4.8, 4.4 and 4.8 respectively in first semester of the M.Tech. programme. Both DMPC and SMPC have not recommended them for continuing in the programme. The Committee resolved to accept the recommendations of SMPC, that these students may not be allowed to continue as per ordinances.

(viii) Committee considered the recommendation of SMPC and DMPC of Mechanical Engineering Department, regarding the case of **Mr. Anurag Dixit (2015PD17)**. Mr. Dixit was granted semester leave for odd semester of session 2016-17. Now Mr. Dixit has requested for extension of semester leave for even semester of session 2016-17 and permission to complete thesis work at his place of job (NPCIL). On the recommendation of DMPC and SMPC, the Committee recommends that the student may be granted semester leave for even semester of session 2016-17. The student has to register in odd semester of session 2017-18 after getting leave and submission of NO Objection Certificate from the employer to complete the residential requirement and the thesis work. The request to work at the place of job was rejected by the Committee.

The student was allowed to register with submission of late fee imposed for such cases. Department shall submit the leave granted to the student during the said period. Further, **Mr. Varun Kumar (2015VL12)** was also allowed to register with late fee imposed for such cases.

(x) Committee considered the case of **Mr. Abhinav Badal Soren (2015PS14)** a student of M.Tech. IV semester (Power System) regarding request to register on or after January 15, 2017. He was absent from the department since 19.12.2016. The candidate has given an Email on 04.01.2017 to his supervisor, that he is suffering from jaundice. The committee recommends semester leave for the student for even semester of session 2016-17.

(xi) Committee considered the case of **Mr. Sharad Chandra (2015EE03)**, **Mr. Awadhesh K Singh (2015EE05)**, **Mr. Amit K Vishwakarma (2015EE10)** and **Mr. Ram Mohan Pandey (2015PS02)** regarding absence without information. They were given warning letter by the department but they have not responded. The Committee recommends the termination of above students on the recommendation of DMPC and Chairman SMPC.

(xii) The Committee considered the recommendation of DMPC of Department of Humanities and Social Sciences and Chairman, SMPC, regarding mercy of **Ms. Swati Singh (2015MW04)**. The student was suffering from spondylitis and was suggested forty days rest, as per the certificate issued by the Doctor, from 22.11.2016 to 30.12.2016. She was not able to appear in two papers of end semester examination for odd semester of session 2016-17 and got F grade in those papers. She secured 4.83 S.P.I. and C.P.I. equal to 7 in III semester examination. The committee considered the case and recommends that she may be allowed to continue the programme. She may clear the two papers in supplementary examination 2017.




