MNNIT Allahabad, has taken the following welfare measures: 24x7 Anti Ragging Helpline Numbers were widely communicated through Notice Board, Institute website etc. Institute appoints Anti-Ragging Committee and an Anti-Ragging Flying Squad to prevent any ragging incidents. A Committee of wardens (Boys / Girls) is constituted in the Institute to council the first year students. Further regular counseling of students is being conducted by Faculty Incharge counseling (Boys) and Faculty In-charge counseling (Girls). To distress the mental tension of the students, the Student Activity Centre (SAC) in regular intervals organize motivational lectures, sports meet, cultural meet to inculcate healthy atmosphere among students. Also, a Yoga Instructor is appointed in the Institute to conduct regular yoga sessions.
