
**Notice**


As per the decision of the Office of Chief Proctor in its Meeting held on 02/08/2019 and its subsequent approval by the Competent Authority, the following notification is issued regarding use of motorized vehicle by married students of the Institute, who reside outside hostels and for hostellers either married or unmarried.

1. All students who are availing the facility of Institute hostel shall abide by the rules already framed for not using any type of motorized vehicle within the Institute campus (academic+hostel). If any such student will be found in the Institute campus either in possession and/or driving/pinion driving will be fined as given below [Letter No.386/CP/2019 dated 25.6.2019]
  - a) In the 1<sup>st</sup> case of use/possession of motorized vehicle : A fine of Rs. 2500/-
  - b) In the 2<sup>nd</sup> case of use/possession of motorized vehicle : A fine of Rs. 5000/-
  - c) In the 3<sup>rd</sup> case of use/possession of motorized vehicle : A fine of Rs. 10,000/-and the concerned student will also face the Proctorial Board.
2. If any student is not availing hostel facility of the Institute, then he/she may be issued a parking pass (Red color) by In-charge Security to park his/her motorized vehicle near the Ganga Gate/Saraswati Gate/Yamuna Gate. He/She is not be allowed to use motorized vehicle within Institute campus. If any such student will be found in the Institute campus either in possession and/or driving/pinion driving will be fined as per the approval granted vide reference No.386/CP/2019 dated 25.6.2019 (as mentioned above).
3. For some special genuine cases, on the recommendation of the concerned Supervisor and Head of the Department, a Ph.D. scholar (who is not a hosteller) may be allowed to park his/her motorized vehicle in the parking lot near his/her department. A separate pass (Green color) shall be issued by In-charge Security for such cases.
4. The student must apply (in prescribed format) for Red Pass (parking) or in special genuine cases for Green Pass in the Office of Chief Proctor after forwarding by concerned supervisor and Head of the Department. A fee of Rs.150.00 will be charged for issue of red/green passes.
