Item No. 75.01 : To confirm the minutes of the Seventy-fourth (74th) meeting of the Senate held on July 19, 2022.

Item No. 75.04 : To consider the progress of implementation of National Education Policy (NEP) – 2020 in the Institute by discussion and finalization on B.Tech. Course Structure & Curriculum & adopting NEP-2020 w.e.f. A.Y. 2022-23.

Resolution : The Senate deliberated on the progress of implementation of National Education Policy (NEP) – 2020 in the Institute and finalization on B.Tech. Course Structure & Curriculum & adopting NEP-2020 w.e.f. A.Y. 2022-23.

The senate also considered the comments of Prof. P.P.Sahay relating to 1st Year B.Tech Curriculum. It was informed to the Senate that the 1st Year B.Tech Curriculum has been evolved in line with NEP 2020 and considering the best practices as practiced in high ranking technical Institutions of the Country. It was also resolved that the departments that are not awarding under graduate degree(s) may float minor programs to enhance technical capabilities of the students.

The senate also noted the observation of the Dean [Academic] regarding the resolution 74.04(a) for replacing " B.Tech 1st Semester" by "B.Tech 1st Year" and deleting the word(Common Syllabus) as the Committee has submitted recommendations for B.Tech 1st Year Course Structure and Curriculum which has branch specific structure and content and not a common course structure and content

The report of the Committee under the Chairmanship of Prof. S.S. Narvi constituted for preparation of B.Tech. 1st year Course structure and Curriculum in-line with NEP-2020 has already been accepted in the 74th Senate meeting.

The Senate reviewed the progress in implementation of NEP 2020 and noted the following :

- (i) The B.Tech 1st Year branch specific course structure and content has been prepared and processed through DUGC, BoAC and SUGC in accordance with the recommendations of the committee constituted under the Chairmanship of Prof. S.S.Narvi.



- (ii) The credit based Extra Academic Activity Course works as envisaged in NEP 2020 for personality development, human skills development and physical and mental well-being of students have been evolved through a curriculum development workshop with subject experts from AU, BHU, IGNOU, UPRTOU held on 24-09-2022.

The course structure & course content and evaluation pattern have also been designed in consultation with subject experts. These Extra Academic Activity Course works will be jointly coordinated the Department of Humanities and School of Management Sciences, MNNIT Allahabad Prayagraj by engaging expert faculty from the outside on an honorarium basis . These course works have also been processed through a duly approved BoAC consisting of members of BoAC of SMS and HSS Department of the Institute with Head SMS & Head HSS Department as the convenors. The recommendations of the BoAC were placed before the SUGC for considerations and have been included in the recommendations of the SUGC.

(iv) The B.Tech with Honours will involve branch specific related advanced courses that will enhance professional competence of students with deeper

and intense application learning, while the B.Tech with Research will involve research focussed advanced courses in one specific specialization. The courses may be all from M.Tech Programme or specially designed reserach centric. Further as per NEP 2020, graduates having 4 year B.Tech with Research will be able to take admission in PhD directly and can also obtain M.Tech degree in one year may be only by writing a thesis. The B.Tech with Research will also enable Integrated B.Tech – M.Tech Program.

- (v) The Minor(s) will be offered by all the department including those which are not awarding Bachelor degree for facilitating students to have multi disciplinary learning and skill enhancing undergraduate programs. More than one minor may be offered by a department ,however at least one minor should invariably be offered by each department/school/cell.
- (vi) Departments in consultation with the Office of the Dean [Academic] would evolve a methodology to notify, allot and manage various B.Tech Programmes in a department.
- (vii) Existing Ordinances for Bachelors' Programme will be modified to administer and regulate the proposed Bachelors' Programme.

The generic titles of the programmes proposed by the Committee are approved in principle, however they may be refined by a committee in consultation with Heads of the Departments/ Chairperson of the Cell. The same Committee may also propose suitable generic codes for different categories of courses being proposed under these programmes and the titles of the multi-exit option(s) associated with exit by a student as per NEP-2020 provisions.

The Senate considered the progress in implementation of NEP 2020 in the Institute and resolved to adopt NEP 2020 with effect from academic year 2022-23 and advised HODs of different departments to finalize the course content of proposed programs including the BoAC recommendations and their presentation to the SUGC and subsequent approval by the Chairman Senate latest by 25-10-2022.

The Senate also resolved to encourage young faculty for their association in SRC formation.
- (iii) The Senate considered the proposal of Prof. Vijaya Bhaduria , Prof. ECED and Dr.Divya Kumar, Assistant Professor, CSED regarding joint study/research work on 5G networks submitted by Indian Air Force, Prayagraj and resolved to approve the same by permitting to offer Part Time/ Regular PG Programme(s) with-in the available suitable approved M.Tech programs in addition to regular PhD admissions from the Even Semester of academic year 2022-23.
- (iv) The Senate considered the recommendations of committee relating to issuing of equivalence certificate for M.Tech (Fluid Engineering) programme of AMD and various other M.Tech Programmes being offered by AMD Department and ratified the following as per the minutes of meeting of the Sub-Committee of Senate (Standing Committee) held on 29.09.2022

"The recommendation of the committee relating to issuing of equivalence certificate for M.Tech (Fluid Engineering) programme of AMD was considered and accepted with a remark that equivalence of M.Tech degrees is not possible as each M.Tech Programme is a specialized programme and establishing an equivalence will lead to loss in specificity and academic/ professional value of the programme. It was also resolved that the M.Tech degree certificate may also be re-designated as M.Tech (Major/core branches of Engineering and Technology) with specialization (Programme Name) to establish broad correlation.



It was also resolved that the gazette notification "ALL INDIA COUNCIL FOR TECHNICAL EDUCATION NOTIFICATION, New Delhi, dated the 28th April, 2017 Major / Core Branch of Engineering / Technology and their relevant / appropriate courses leading to degree in Engineering / Technology for recruitment to teaching position" may be used for establishing equivalence between different programmes at UG & PG level.

The information relating to all the M.Tech Programmes may be provided to the AICTE for establishing an equivalence and gazette notification. Further, AICTE may also be requested to consider all the offered programmes of the Institute for equivalence as and when approved by the Senate, MNNIT Allahabad, Prayagraj."

The meeting concluded with the vote of thanks to the Chair.

- "Item No. 71.04** : To discuss the progress of implementation of National Education Policy (NEP) – 2020 in the Institute.
- Resolution** : The Senate considered the proposal of Dean (Academic) on credit transfer and adoption of MOOCs courses as a part of the NEP-2020.
- The Senate after deliberations resolved to accept the guidelines of SWAYAM [Ref. UGC (Credit Framework for Online Learning Courses through SWAYAM Regulation, 2016, New Delhi, the 19th July, 2016)] in principle with a 20% ceiling on maximum number of courses a student can opt as MOOCs courses.
- The Senate also resolved to float a minimum of 5 MOOCs courses as open elective for final year curriculum in the academic year 2021-22 having at least 02 credits. These courses will be floated by the different academic departments of the Institute.*

1. The Committee discussed the recommendation of the DDPC of Department of Computer Science and Engineering regarding on the of Ms. Charu Krishna (2020RGS02) regarding

The Committee considered the case and approved her request. She has to deliver State of Art seminar within 15 days from notification of this approval.

- The Committee discussed the recommendation of the DDPC of Department of Biotechnology on the request of Mr. Ankit Kushwaha (2016RBT03), regarding three month extension for his thesis submission which was due on September 13, 2022.

The Committee approved the same as per clause no. 13.1 of Doctoral Programme Ordinance.

- The Committee discussed the recommendation of the DDPC of GIS Cell on the request of Mr. Kaushal Kumar (2016RGI01), regarding three month extension for his thesis submission which was due on September 19, 2022.

The Committee approved the same as per clause no. 13.1 of Doctoral Programme Ordinance.

- The Committee discussed the recommendation of the DDPC of Department of Electrical Engineering on the request of Mr. Vivek Patel (2017REE02), regarding conversion of his Ph.D. program from regular to part time. He has completed all the requirement for conversion as per clause 4.5 of the Doctoral Programme Ordinance.

The Committee approved the same as per clause 4.5 of Doctoral Programme Ordinance.

- The Committee discussed the recommendation of the DDPC of School of Management Studies for permitting Ms. Akanksha Srivastava (2021RMS51) to opt for one course from SWAYAM/ MOOC'S courses, in accordance with clause 7 of Doctoral Programme Ordinance.

The Committee resolved to allow the same as it is permissible under the New Doctoral Programme Ordinance clause no. 7.1 point 4.

- The Committee discussed the recommendation of the DDPC of School of Management Studies on the request of Ms. Vaishali Pandey (2022RMS07) for transfer of her Ph.D course credits from IIT Jodhpur (where she was initially enrolled) to MNNIT Allahabad.

The DDPC of SMS recommends that as no provision for such transfer of credits exists within the New Doctoral Programme Ordinance, therefore the DDPC of SMS turned down the request of the candidate.

The SDPC committee approved the same.

- The Committee discussed the recommendation of the DDPC of Mechanical Engineering Department on the request of Mr. Atul Kumar Ahirwal (2021RME52), regarding crediting of the 3 SWAYAM course for odd Semester of session 2022-23.

As per senate resolution no. 71.04 there is a 20% ceiling on maximum number of courses a student can opt as MOOC's courses, however Mr. Atul Kumar Ahirwal being a part time candidate cannot attend offline courses in the Institute.

In view of above, the Committee referred this case to standing committee.

8. The Committee discussed the recommendation of the DDPC of Department of Electrical Engineering on the request of Mr. Satyaprakash (2016REE09) regarding extension of the Ph.D. program by one year starting from July 2022.

The SDPC revert his application to the Department and seeking clear recommendation of the DDPC of the Department.

9. The Committee discussed the minutes of the DDPC of Department of Civil Engineering on the request of Mr. Govind Jha (Reg. No. 2021RCE04) regarding cancellation of termination from Ph.D program.

The committee observed that his program is not terminated rather he had ~~not~~ requested the withdrawal of his Ph.D programme to join SSC-JE (Border Road Organization) which was allowed by the committee provided candidate has to take no-dues from the Institute. As per his application he joined the job.

In view of above, the SDPC revert back his case to the Department and advised to bring all the details of the candidate for consideration.

10. The Committee discussed the minutes of the DDPC of Department of Civil Engineering regarding the remark of the Director on the request of Mr. Santosh Kumar Gupta (2021RCE57) and Mr. Rajesh Kumar Srivastava (2021RCE55). The DDPC of Civil Engineering Department mentioned that "Chairman Senate has already approved for consideration of M.Tech credential of the students."

The SDPC deliberated in detail and recommend that, this recommendation of DDPC is revert back for submitting approval of Chairman Senate.

11. The Committee discussed the recommendation of the DDPC of Applied Mechanics Department on the request of Mr. Mohit Kumar Pandey (2021RAM53), seeking permission to continue his Ph.D program and replacement of one subject.

The Committee considered the case and resolved to recommend the revoke of termination of Mr. Mohit Kumar Pandey (2021RAM53), as per clause 8.2 of New Doctoral Programme Ordinance and replacement of one subject.

12. The Committee discussed the recommendation of the DDPC of Department of Mathematics on the request of Mr. Nikhil Kumar (Reg. No. 2021RMA04) regarding conversion of his Ph.D. program from regular to part time. He has completed the course work, passed comprehensive examination, but he has not given State of Art seminar.

As per the clause no. 4.5 of New Doctoral Programme Ordinance "A student requesting such conversion must have complete the coursework, passed the Comprehensive Examination, given the State of the Art Seminar which is adjudged as satisfactory, and completed the residence requirements".

However based on the recommendation of DDPC the committee recommends that as the candidate selected for a teaching post (Assistant Professor through Uttar Pradesh Higher Education Commission), he may be allowed to convert his candidature from regular to part time, as a special case in accordance with clause no. 17 of New Doctoral Programme Ordinance. Further it may not be treated as precedence for future cases.






The Committee considered the case and resolved to recommend the same as per clause 5.3 of Doctoral Programme Ordinance.
