- In the event of tie in scores of candidates in CRENIT-2023 Examination, merit will be decided by applying the following criteria, one after another in the given order, till the tie is resolved:
 - (i) The candidate having higher age (in Years, Months & Days) will get preference in merit.
 - (ii) If the candidates are having the same age, then higher percentage/CGPA in minimum essential educational qualification will get preference in the merit.

- i. A signed copy of the printout of application form submitted by you at the time of applying for the post.
- ii. High School certificate or equivalent as proof of your date of birth/ age;
- iii. Certificates and Mark-sheets of educational qualifications, as claimed in your application.
- iv. Valid Caste certificate in the prescribed format as applicable for employment in Central Government Organizations (If applicable).
- v. Disability certificate issued by the competent medical authority as applicable for employment in Central Government Organizations. (If applicable).
- vi. No Objection Certificate [NOC] from persons serving in Government/ Semi-Government/ Autonomous Bodies/ Statutory Bodies/ PSUs/ PSBs (If applicable).
- vii. Admit Card.
- viii. Photo Identity Card as mentioned in the application form.
- ix. Two Passport size color photographs.
 - Without the above-mentioned supporting documents, the candidates will not be considered for further selection process.
 - Recruitment will be made as per the vacancies advertised against each category and Recruitment Rules of NITs and the merit list based on the CRENIT-2023 Examination conducted by the NTA.
