Please refer to your email dated 26.07.2023 on the above mentioned subject. In this connection, the desired information in respect of MNNIT Allahabad is as follows:

(a) whether it is a fact that Government proposes to layout guidelines for Universities to ensure basic facilities and amenities for a secure environment for female students;

MNNIT Allahabad conducts various training programmes to sensitize the employees/ students of the Institute about gender related issue and they were informed about Internal Complaints Committee and process to address their complaints to Internal Complaints Committee in case they have any.

Also, Orientation Session for first year B.Tech students were conducted, wherein the Chairperson ICC addressed the Students and informed them about process to address their complaints to Internal Complaints Committee in case they have any. The students were sensitized about various gender related issues and they were also informed about Internal Complaints Committee constitution and how to contact the ICC.

(b) whether the Government has a proposal to recommend the setting up of women cells in Higher Educational Institutions for sensitization and policy implementation, monitoring and grievance redressal; and

The Institute has already constituted the Internal Complaint Committee [ICC] and the Special Cell constituted vide Notice No. 657/Admin.-II off./2021-22 dated 13.12.2021 and constituted vide Notice No. 2519/ Admin.-II Off./ 2021-22, dated 31.03.2022 respectively.
