Applications are invited from Indian nationals for the post of Junior Research Fellow (on contract) in research project entitled “**Computational screening to identify plant derived DPP IV inhibitors as therapeutics of diabetes type 2**” sanctioned vide letter no. CRG/2022/002804 dated 19/12/2022 and sponsored by SERB, New Delhi.

**Description and Objectives of the Project:** We aim to screen DPP-4 inhibitor herbal peptides by using computational approaches. The objective is to develop a computational tool for easy screening of DPP-4 inhibitor peptides based on models derived from binding affinity between the receptor and ligands. Additionally, a repository of anti DPP IV plant based peptides will be developed.

The position is purely temporary. It will be governed by the funding agency rules & service conditions of Office of the Dean (Research & Consultancy), MNNIT Allahabad.

**Essential Qualifications** : M.Tech./M.Sc. in Bioinformatics, Biotechnology, Life Sciences, Biochemistry, Molecular Human Genetics, Molecular Biology or any relevant discipline suitable to the work proposed in the project. NET and/or GATE qualified

**Fellowship** : Rs. 31,000.00 per month + HRA @ 16 % (or as per Funding agency guidelines)

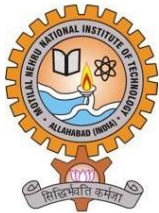

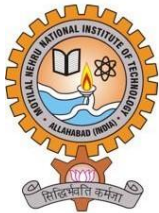

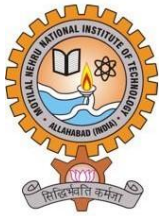
